## MEMORANDUM OF UNDERSTANDING INNOVATION PARTNERSHIP AGREEMENT

#### **BETWEEN:**

CITY OF NEW WESTMINSTER NEW WESTMINSTER, BRITISH COLUMBIA

#### AND:

NEW WESTMINSTER SCHOOL DISTRICT NEW WESTMINSTER, BRITISH COLUMBIA

#### WHEREAS:

- A. The City of New Westminster, as an Intelligent City, applies information and communications technology (ICT) to create a climate for innovation so businesses, institutions and all citizens have every opportunity to thrive in the new digital economy, and in doing so positions itself as a sustainable economic hub in Metro Vancouver.
- B. The City of New Westminster is focused on its strategic goal that by '2020, New West will be the leading candidate for new, digital media and technology centric companies, in Greater Vancouver' and will work collaboratively with schools and institutions in New Westminster to achieve this goal.
- C. New Westminster School District has established a blueprint for learner success outlining four important themes that guide their work: These include Engagement and personalized learning; Social and emotional well-being and healthy lifestyles; Communicating student learning; and Technology and Learning.
- D. New Westminster School District recognizes that technology is a transformational educational tool for teaching and learning and is undertaking significant structural upgrades in their district and developing a strategic plan focused on employing those technologies that optimize learning for students including Science, Technology, Engineering, Arts and Math (STEAM).

There are significant benefits to both the City of New Westminster and the New Westminster School District, in working together toward the achievement of goals related to the future of the city's students and Intelligent New West.





#### NOW THEREFORE, THE PARTIES AGREE AS FOLLOWS:

#### 1. Objective

The Agreement formally acknowledges the partnership between the **Parties** in order to promote effective collaboration between them in regards to digital innovation in education.

#### 2. Areas of Potential Collaboration

The **Parties** will collaborate to further the shared goals of digital inclusion through activities including but not limited to:

- a. Active participation as key partners on respective working team committees;
- b. Enhance connections between creative learning spaces and industry employing the new city fibre network to advance digital education;
- c. Work together to determine what future knowledge workforce and other related skills and resources are needed for all levels of learners in digital media and technology, including identifying and incorporating resources such as STEAM New Media Gallery and Anvil Learning Lab;
- d. Continue with the Intelligent New West and School District's focus on arts and culture with an increased emphasis on future innovation, creativity and youth entrepreneurialism in sectors such as digital media by encouraging students at all levels to participate;
- e. Work together to determine what facilities / structures/ resources and approaches will are needed to support the growth of innovation and the knowledge workforce in the city and in schools into the future.





#### **Not Legally Binding**

This **Agreement** is not intended to be and is not to be construed as a legally binding agreement. Signing of this **Agreement** does not result in any material, financial or other obligation for either of the **Parties** hereto.

#### Representatives

The representative from the City of New Westminster for this **Agreement** is the Manager of Economic Development and Communications. The representative from New Westminster Schools for this **Agreement** is the District Associate Superintendent.

#### Term

This **Agreement** will be valid for a period of 3 (three) years and will become effective on the date it is signed by all **Parties**. This **Agreement** may be extended or amended with the written agreement of both Parties and may be terminated by either **Party** with 90 days written notice to the other **Party**.



Re: Queen's Park Heritage Conservation Area, Returning Protection to 207/209 St. Patrick Street

We are contacting you in relation to the Heritage Conservation Area, which was implemented in the Queen's Park neighbourhood of New Westminster in June 2017. The goal of the Heritage Conservation Area is to retain the existing heritage values of the neighbourhood while, at the same time, managing change. Houses in the Queen's Park Heritage Conservation Area are categorized as either Protected or Non-Protected. Based on the protection level, owners may be required to apply for a Heritage Alteration Permit for certain renovations, to demolish a home, to build a new home, or to build a laneway or carriage house.

Through the Heritage Conservation Area policy development process, approximately 80 properties were identified for further study, and 34 of those had their Heritage Conservation Area related protection removed based on the results of the first phase of this study.

At the Public Hearing for the bylaw removing protection from those 34 properties, the property owner of 207/209 St. Patrick Street requested that their property remain protected instead. Following adoption of the bylaw, Council directed staff to process an Official Community Plan (OCP) Amendment in order to return that property's protection, per the owner's request. As a Heritage Conservation Area forms part of the City's Official Community Plan (OCP), the OCP must be amended in order to re-classify a property from Non-Protected to Protected. The location map and Heritage Assessment for 207/209 St. Patrick Street are attached to this letter.



A Public Hearing is being held for the OCP Amendment to return this property to Protected status on Monday September 17 at 6:00pm at the Queensborough Community Centre, 920 Ewen Avenue, New Westminster. More information about the Public Hearing and all supporting materials can be found at this web page: <a href="https://www.newwestcity.ca/publicnotices">www.newwestcity.ca/publicnotices</a>. As a relevant stakeholder, we hope that you will take an opportunity to review the background materials and reports on our website.



#### **Heritage Status**

#### **Context and Siting**

The subject house is located on a small square shaped property near the intersection of St. Patrick and Second Streets. St. Patrick is a short street lined with mature cherry trees. The house is situated towards the front of the lot closer than other houses on the block fronting St. Patrick Street.

Single detached dwellings surrounding the property share similar massing and form but were built in widely varying ages, ranging from 1910 to 2010.

#### **Description**

The building at 207-209 St. Patrick Street is a one-and-one-half storey with basement wood frame house constructed in 1927. This modest home was built in the cottage style popular in New Westminster during the 1920s and 1930s. It features a symmetrical façade with central front door and a large picture window on each side of the entry as well as a gable roof with chamfered ends. Alterations to the house likely included replacement of windows on the front façade (upper and lower levels) as well as the front entry porch, railings and posts.

#### **Heritage Value**

The house at 207-209 St. Patrick Street has some historic significance as it was built during a period of economic growth between the two World Wars and just prior to the Great Depression. The house was originally located closer to the corner of Second and St. Patrick Street. In 1976, a permit was issued to relocate the house to its current location and subdivide the property. A new lot was created at 422 Second Street and the house was constructed the same year. The property is thereby reflective of historic development patterns in Queen's Park over the years.

The house has aesthetic heritage value as it is a good example of the cottage style popular in the Queen's Park neighbourhood, very likely based on the Ripley house plan from a historic house plan catalogue issued by a local lumber company. The house retains its cladding, massing, form and overall character and therefore contributes to the cohesive historic streetscape of Queen's Park.

The house has social value for its contribution to the community identity of the Queen's Park neighbourhood. It also supports the heritage significance of the neighbourhood by: contributing to a unique sense of time and place and representing the middle class. The house at 207-209 St. Patrick Street is not associated with a prominent or long-term New Westminster resident. Further, it does not exhibit any cultural, spiritual or scientific heritage value.

#### **Character Defining Elements**

- Gable roof, side roof ends with chamfering and no roof overhangs
- Projecting front entry porch with square wood posts and railings
- Large wood frame picture windows with window boxes underneath on either side of front entry
- Projection on east elevation with multi-paned small window
- Wood frame double hung window on east elevation upper storey
- Substantial wood trim around windows, doors and on stair railing
- Laminated cedar tile cladding with vertical grooves


