1. Background

In June 2016, the Province of B.C. announced funding for the replacement of New Westminster Secondary School (NWSS). The \$106.5 million project will be the largest school investment in B.C. history. This will be the third recent new school opening in New Westminster, following the opening of École Qayqayt Elementary School in September 2014 and the opening of Fraser River Middle School in September 2016.

Anticipated to open in late 2019, with construction starting in 2017, the new NWSS will accommodate 1,900 grade 9 to 12 students. The new school will provide a state-of-the-art learning environment. It will be designed to optimize the use of flexible learning spaces to maximize collaboration and active learning; this will include technology that enriches the learning process, multi-purpose spaces and modern shops, as well as contemporary fine and performing arts spaces. It will also meet today's standards for modern learning, safety and accessibility, and incorporate the latest sustainable energy and waste management systems.

Built in 1949, the current school has served New Westminster students exceedingly well, but the facility is outdated and requires seismic remediation. It is the only secondary school in the City of New Westminster and one of the largest in B.C., which will be a key consideration in planning and building the new school. Also importantly, part of the property is located on a former burial area. Commitments have been made that no construction will take place on any known burial area.

HOW INPUT WILL BE USED

Input received during this round of community consultation will be considered, along with financial and technical information, in the design for the new secondary school.

2. Memorialization Advisory Committee

We are continuing to engage with First Nations communities, the Chinese Benevolent Association, the Legacy Initiatives Advisory Council, Inclusion BC, and other organizations that represent communities with a history or potential history of ancestral burials on the site. As the project moves into the design stage, the School District will lead a Memorialization Advisory Committee (MAC) that will engage with First Nations, the Chinese community, Inclusion BC and other affected communities.

We are working with these organizations to better understand their views and preferences regarding the ongoing planning and investigation work. We will continue to engage with affected communities and gather their input on how best to memorialize the dedicated and protected areas of the site that are known to have been used for burials.

3. Round 1 Community Consultation: November 7 – December 5, 2016

3.1 PURPOSE

This round of community consultation provided participants with information about the New Westminster Secondary School Replacement Project and gathered input on the project aspirational statements. Feedback from this round of community consultation will be considered, along with financial and technical information, in the design for the new secondary school.

Further community consultation opportunities are planned for 2017.

3.2 CONSULTATION PARTICIPATION

There were a total of **214** public and stakeholder interactions during the NWSS Replacement Project Round 1 community consultation period:

- 102 completed feedback forms were received (87 online, 15 hard copy)
- **86** people attended two public open houses
- 21 people attended two small group meetings
- **5** written submissions were received through email or mail

3.3 CONSULTATION TOPICS

The Board of Education for the New Westminster School District developed 10 project aspirations for designing and building the new school. During this round of community consultation, participants were invited to provide feedback on the following project aspirations:

- 1. Build a school that will support the evolving learning environment
- 2. Create a school with the flexibility to meet the needs of a rapidly changing society
- 3. Develop a sustainable design that will minimize impacts on the environment
- 4. Develop a design with an emphasis on healthy students, teachers and staff
- 5. Respect, protect and preserve the historical and cultural significance of the site
- 6. Create spaces that consider the role of rapidly changing technology in the ways students learn
- 7. Create opportunities for school community engagement
- 8. Create learning spaces where students and staff interact outside of the traditional classroom environment
- 9. Make teaching and learning spaces visible
- 10. Design a school that inspires and nourishes creativity

3.4 NOTIFICATION

The community was notified about consultation opportunities through the following methods:

- **Newspaper Advertising:** Advertisements ran in the *New Westminster Record* on the following dates:
 - Thursday, October 27
 - Thursday, November 3
- **Postcard Notification:** Postcards were distributed to approximately 4,000 households and businesses in New Westminster. Postcards were also placed at nearby community centres.
- **Poster Notification:** Posters were placed at nearby community centres, grocery stores and throughout New Westminster schools.

Stakeholder Emails:

- All principals of New Westminster schools (including adult and online learning programs) emailed approximately 6,800 parents and guardians regarding the consultation period.
- An email was sent to approximately 100 stakeholders to notify them about consultation opportunities.
- The Parent Advisory Committee was sent email notification about the community consultation.
- **Social Media:** Two tweets were sent from @newwestschools, and several tweets and Facebook posts were retweeted and posted from other NWSS program-specific accounts, as well as from the NWSS principal and school board trustees.
- **Consultation Website:** All community consultation materials were available on the project website at newnwss.com.

3.5 ENGAGEMENT METHODS

3.5.1 Discussion Guide and Feedback Form

The discussion guide provided information on the replacement project, the Memorialization Advisory Committee, the history of the site and the 10 project aspirational statements.

The feedback form asked respondents to provide their level of agreement, with reasoning, for 10 aspirational statements and to provide any additional aspirations or comments they may have on the project. The feedback form was distributed at open houses, small group meetings, local community centres and posted online at newnwss.com.

A copy of the discussion guide and feedback form can be found in Appendix 2.

3.5.2 Online Materials

Community consultation materials (discussion guide and feedback form) were available online at newnwss.com. The website also provided an overview of the project and the schedule for the consultation events. Of the 102 completed feedback forms, **87** were received online.

3.5.3 Open Houses

Two open houses were held in New Westminster to allow community members to discuss the project with team members and to learn more about the project aspirational statements. Large display boards were set up around the room with information from the discussion guide to aid in discussion with participants and the project team.

4.1 FEEDBACK FORMS


The following are results from the **102 completed feedback forms received** at the open houses, small group meetings, online and by mail.

Please note that quantitative results are displayed by number of selections. The number of mentions for qualitative data may exceed the total number of respondents, as participants may have commented on more than one topic.

Question 1: Please indicate your level of agreement with the following project aspirations.

1.1 Build a school that will support the evolving learning environment

The vision for the new NWSS is strongly aligned with the redesigned curriculum, which focuses on student-centred learning. Spaces in the new school will be designed with the flexibility to encourage both collaborative learning in large groups and smaller one-on-one sessions as needed.





- Request to move grade 9 students to the middle school and build an additional middle school and a smaller high school (grades 10–12).
- Importance of designing fine and performing arts spaces specifically for student needs and to not sacrifice design by accommodating other uses (e.g., daycare and performing arts combination space at École Qayqayt Elementary).
- Importance of smaller classroom sizes.
- Need to ensure teachers are still available to guide student-centred learning.
- Request that classroom design offers some privacy to reduce learning interruptions.
- Concern that budget will lead to program cuts.
- Request for eating areas.
- Importance of student engagement though involvement in extracurricular programs; need for ensuring these programs are a priority alongside academic programs.
- Suggestion that Royal Bay High School is a good example of architecture and open learning spaces.
- Request for community involvement in student-centred learning spaces.

1.2 Create a school with the flexibility to meet the needs of a rapidly changing society

The new NWSS will not just be a school but a 'community' or 'village' in which different groups of students find themselves crossing paths and interacting with others in ways that might not have been possible before. The environment will encourage interaction and collaboration between different parts of the school community.





1.3 Develop a sustainable design that will minimize impacts on the environment

The new NWSS should be designed and built to have minimal environmental impact. The building should incorporate innovative energy and water conservation technology. Where possible, the building should use locally sourced materials and labour.





1.4 Develop a design with an emphasis on healthy students, teachers and staff

The new NWSS is envisioned as a place that feels safe (physically, emotionally and socially) for students, teachers and staff. The design must incorporate community gathering and collaborating spaces as well as quiet spaces to reflect and de-stress. As much as possible, students, teachers and staff should have access to fresh air and natural light.

1.5 Respect, protect and preserve the historical and cultural significance of the site

The new NWSS will be built adjacent to the site of the old school, which has important historical and cultural significance to First Nations communities, the Chinese community and other communities who have ancestors who may have been buried on the property. The School District has committed not to build on any known burial area, and to protect, preserve and memorialize the burial areas. A Memorialization Advisory Committee will advise the School District on appropriate ways to honour the history of the site. Students will be engaged in the memorialization as an ongoing part of the academic program.

1.6 Create spaces that consider the role of rapidly changing technology in the ways students learn

The new provincial curriculum places technology at the forefront of learning, and the new NWSS will be designed with the flexibility to accommodate the most advanced learning tools and technology updates. The school will seek to meet students' need for information (seeking and sharing) on a 24/7 basis.



1.7 Create opportunities for school community engagement

Active student engagement is integral to promoting a positive school community. The new school building will promote engagement and interactions through multiple gathering spaces that offer unique environments for students, teachers, staff and parents to come together. The 'village' environment will feel welcoming to new students while at the same time honouring the past. The school environment will engage all learners, including those most at risk.

The school will be designed to encourage student learning in a variety of places and spaces outside of the traditional classroom setting. Consideration will be given to creating spaces for activities such as welcoming and orienting new students, meditation, mentoring and socializing.

1.9 Make teaching and learning spaces visible

The school design will create learning spaces that are open and encourage collaboration. Teaching will rarely happen in isolation. Instead, it will be observable and transparent to the rest of the school community in ways that encourage curiosity and participation.



1.10 Design a school that inspires and nourishes creativity

The new NWSS will have a simple but elegant design that encourages and nurtures creativity. The space will be inspirational and foster in students and teachers an eagerness to push boundaries and seek excellence.
