### 1. Background

In June 2016, the Province of B.C. announced funding for the replacement of New Westminster Secondary School (NWSS). The \$106.5 million project will be the largest school investment in B.C. history. This will be the third recent school opening in New Westminster, following the opening of École Qayqayt Elementary School in 2014 and Fraser River Middle School in 2016.

Scheduled to open in September 2020, with construction completed in the spring of 2020, the new school will accommodate 1,900 grade 9 to 12 students and will provide a state-of-the-art learning environment. It will be designed to optimize the use of flexible learning spaces to maximize collaboration and active learning. This will include technology that enriches the learning process, multi-purpose spaces and modern shops, as well as contemporary fine and performing arts spaces. It will also meet today's standards for modern learning, safety and accessibility, and will incorporate the latest sustainable energy management systems.

In December 2017, the New Westminster School District and the Ministry of Education selected Graham Design-Builders with KMBR Architects Planners Inc. to design and build the new school, based on their proven expertise in this area, on their ability to deliver on time and on budget, and on an extensive and thorough understanding of the project's Statement of Requirements.

The school will be designed and constructed in two phases. The design of Phase 1, which includes most aspects of the new school—including teaching and learning spaces, visual and performing arts spaces, athletic facilities and administration space—is almost finalized, with the exception of some elements that may be revised based on input from this consultation. Phase 2 includes deconstruction of the existing school, design and construction of the surrounding grounds and access, and design and construction of the memorialization area.

### 2. Memorialization

### 2.1 PROTECTED AREAS

Both the Province of B.C. and the New Westminster School District made a commitment to protect and preserve the historical significance of the site and to ensure that no construction will take place on any known burial areas. The New Westminster Secondary School Replacement Project is dedicated to meeting this commitment.

To confirm buildable locations for the new school, Golder Associates, on behalf of the School District, conducted a heritage investigation and archaeological impact assessment of the project site in 2016. Based on previous and recent studies, we are satisfied that there are no known burial areas in the anticipated location of the new school.

Heritage management and archaeological monitoring procedures will remain in place throughout the construction of the new school.

### 2.2 MEMORIALIZATION ADVISORY COMMITTEE

We continue to engage with First Nations communities, the Chinese Benevolent Association, the Legacy Initiatives Advisory Council, Inclusion BC, and other organizations that represent communities with a history or potential history of ancestral burials on the site. A Memorialization Advisory Committee (MAC) has been struck and held its first meeting on June 12, 2017. The committee continues to meet every two to three months to discuss design components and to consider how best to memorialize the dedicated and protected areas of the site that are known to have been used for burials.

The memorialization area is part of Phase 2 of the project and will be developed as a passive park, following the deconstruction of the existing school.

### 3. Round 1 Community Consultation: November 7 – December 5, 2016 (Complete)

Round 1 Community Consultation ran from November 7 to December 5, 2016, with a total of **214** public and stakeholder interactions. Community members participated in the consultation by attending open houses or small group meetings, filling in a hard copy or online Feedback Form, or providing a written submission by email or mail. Round 1 focused on the Board of Education's 10 project aspirations:

- 1. Build a school that will support the evolving learning environment
- 2. Create a school with the flexibility to meet the needs of a rapidly changing society
- 3. Develop a sustainable design that will minimize impacts on the environment
- 4. Develop a design with an emphasis on healthy students, teachers and staff
- 5. Respect, protect and preserve the historical and cultural significance of the site
- 6. Create spaces that consider the role of rapidly changing technology in the ways students learn
- 7. Create opportunities for school community engagement
- 8. Create learning spaces where students and staff interact outside of the traditional classroom environment
- 9. Make teaching and learning spaces visible
- 10. Design a school that inspires and nourishes creativity

#### **WHAT WE HEARD**

The majority of participants strongly agreed with the proposed aspirational statements. Many participants provided specific comments related to the design of the new school, and some expressed an interest in providing feedback on the design in the future. As a result of this feedback, Round 2 Community Consultation focused on topics related to the design of the new school.

#### **HOW INPUT WAS CONSIDERED**

All of these aspirations and feedback from Round 1 were considered during the selection of the design-build team, and in developing the design for the new school.

# 4. Round 2 Community Consultation: February 15 – March 15, 2018

### **4.1 PURPOSE**

This second round of community consultation was designed to provide the community with an opportunity to provide input on some specific design decisions for the new school.

This is the last round of community consultation planned for Phase 1 of the project.

### **HOW INPUT IS BEING USED**

Input received through this community consultation is being considered, along with technical, environmental and financial considerations, in the final design for the new NWSS.



#### 4.2 CONSULTATION PARTICIPATION

There were a total of **256** participant interactions during Round 2 Community Consultation:

- **117** Feedback Forms were received (102 online, 15 hard copy)
- **105** people attended two public open houses
- **27** people attended three small group meetings (one NWSS Parent Advisory Committee (PAC) meeting and two public meetings)
- **7** open-ended submissions were received through email or in hard copy

### 4.3 CONSULTATION TOPICS

Community consultation provided information about Phases 1 and 2 of design and construction for the new school. Feedback topics included:

- Outdoor spaces
- Pedestrian and cyclist access and amenities
- Student pick-up and drop-off areas

There was also an opportunity to provide additional comments and to sign up for construction updates.

### 4.4 NOTIFICATION

Notification activities to inform the community about consultation opportunities included:

- Postcards: Approximately 4,000 postcards were distributed to residents and businesses near NWSS.
- **Posters:** Posters were distributed and posted at New Westminster schools and several local community centres.
- **Print advertisements:** Advertisements ran in the *New Westminster Record* on Thursday, February 1 and Thursday, February 15.
- **Online advertisements:** Digital advertisements ran on the *New Westminster Record* website (newwestrecord.ca) from February 2 to March 2.

#### · Stakeholder emails:

- Three emails were sent to stakeholders and community members who had signed up for updates to notify and remind them about consultation opportunities.
- Principals of various New Westminster schools (including NWSS) emailed parents and guardians about the consultation period.
- The PAC and MAC received email notification about the consultation period.
- **News release:** A news release was distributed to the *New Westminster Record* on Wednesday, January 31.
- Social media: Four tweets were sent from @newwestschools and two posts from facebook.com/newwestschools. Several tweets and Facebook posts were shared by the NWSS principal and School Board trustees.
- **Project website:** All consultation materials, including an online Feedback Form, were available at **newnwss.ca**.

#### 4.5 ENGAGEMENT METHODS

#### 4.5.1 DISCUSSION GUIDE AND FEEDBACK FORM

The Discussion Guide and Feedback Form was divided into two sections: topics for information and topics for feedback. Project information was provided, including background, construction phasing, about the site, and details and renderings of interior features.

The Feedback Form included information and questions related to outdoor spaces, pedestrian and cyclist access and amenities, and student pick-up and drop-off areas. There were four quantitative questions and five qualitative questions, providing respondents several opportunities to write comments. There was also an opportunity to sign up for construction updates.

#### 4.5.2 ONLINE MATERIALS

All materials were available online at **newnwss.ca**, including an online Feedback Form. Of the **117** Feedback Forms received, **102 (87%)** were received online.

### 4.5.3 OPEN HOUSES

**105** people in total attended two public open houses held in New Westminster.

The open houses allowed community members to speak with the Project Team and ask questions about the project. Display boards and a large roll-out map were set up around the room, mirroring information from the Discussion Guide to facilitate discussion. Hard copy Feedback Forms were available and attendees were encouraged to complete the Feedback Form during the session, at home or online.


### 4.5.4 SMALL GROUP MEETINGS








