- Lord Kelvin Elementary School: Kristie participated in a fantastic workshop put on by Serena Mani, and Lauren Carter, educator, and author of the book 'Nice Spot' – a book about outdoor learning.
- NWSS: the First Peoples Course an indigenous grad component is being run this semester. Many teachers at the school would like to see an indigenous facilitator be hired to help with indigenizing the curriculum for this course.
- Teachers support the addition of frosted glass and/or blinds to mitigate the glass and uncovered walls.

CUPE 409: Dave Bollen, President

- President Bollen and Vice-President Janet Kinneard have been elected back into these positions. Erica Bigland will serve as the new CUPE secretary.
- CUPE AGM will be held on Saturday, February 25th, 2023.
- Bollen stated that he has visited three different schools in the last two weeks with the goal of finding different ways to help create a safe work environment.
- Collective Agreements have been ratified, and are waiting for the retro pay adjustment.

7. REPORTS FROM SENIOR MANAGEMENT

a. Superintendent Update (K. Hachlaf)

School Learning Plans: Superintendent Hachlaf continues to participate in 'school learning plan visits,' and provided an update on the following activities.

- NWSS: Principal Murray McLeod toured Hachlaf through several classes including the Sigma program, and the Welcome and Wellness Centres. Hachlaf stated that Shrek the Musical is still taking place, and he looks forward to attending.
- Home Learner's Program, Ecole Herbert Spencer, QayQayt & Connaught Heights: Superintendent Hachlaf acknowledged and thanked all the students that led him on their school wide tours.
 - Other updates include Continuing Education Adult Programs: District Vice-Principal Stephen Innes, noted that our enrolment increased by almost 100 from last quarter, taking us to approximately to 450 students.
 - District wide survey: a District-wide survey has been sent out and focuses on looking at continual enhancements, seeking community input on what is working well and where there is need for improvement. Survey will close next Sunday.
 - o Ministry Peer Review: The team will be coming to visit on Thursday, March 2nd and Friday, March 3rd. The team will consist of Ministry staff, a representative from the BC School Trustees Association, Superintendents Association, Métis Nation of BC, and BC Principles and Vice-Principles. These are the focus areas that our team are engaged in and will be reviewing, and the stories and initiatives that frame our work. Hachlaf will report back on the findings and recommendations from the Ministry team.
 - District Professional Development: April 24, 2023, with a particular focus on Indigenous education.
 - i. Diversity, Equity, Inclusion and Anti-Racism (K. Headley)

Vice-Principal Kenneth Headley provided a presentation on Diversity, Equity, and Anti-Racism. Developing a Strategy for Systems Change through Healing, Hope and Joy. Highlights of discussion included the following:

- The Ministry's K-12 Anti-racism Action Plan is a multi-year framework.
- Youth Engagement in our District has included a number of different presentations including, BC Lions for anti-racism, an all grade 8 presentation for anti-racism and equity on January Collaboration Day, Black History Month presentation for K-5 (Love and Resistance of Steelplan Music), Get Real inclusivity presentation for all middle schools, Black Excellence Day Kick off in October 2022.
- Things that are happening: Inclusive calendars have been created and shared with our administrative teams; a newsletter with learning opportunities for diversity, equity, inclusion, and antiracism; a parent website with learning resources; youth engagement; staff website with learning resources, and supporting administration and teachers in dealing with racist incidents at schools and much more.
- Next Steps: to work more closely with schools to develop staff learning and confidence in antiracism practices, to develop an antiracism district committee, and continue to work with our district learning team to align our resources to focus on this work to name a few.

Vice-Principal Headley lost connection to the meeting at 7:53 pm.

ii. Safe Schools Update (M. Smith)

Vice-Principal Melanie Smith provided a Safe Schools Update:

Code of Conduct Reviews started at our schools in September 2022.

- Risk Assessment: the District completed violence risk assessment with Kevin Cameron in the fall of 2022. There have been some updates to this program which we will now begin to implement within our own processes and protocols.
- Collaboration with community support is ongoing with child and youth mental health.
- NWSS Safety Update: currently reviewing options for surveillance cameras, and frosting of the windows. Noon hour supervisors training is ongoing and was part of their review process last fall. NWSS has also implemented a student referral form that teachers can use if they have student conduct concerns and/or mental health concerns. Next Steps: Revising our administrative procedures related to reporting and conduct concerns to ensure they are clear, to formalize tracking of school safety incidents and to use this data to determine the impact of interventions, and to formulize protocols on District communications with external agencies. Smith noted that there have been conduct concerns in the community that spill into our schools, and we are currently looking at formalizing regular standing meetings with the middle school principals and the secondary administrators to ensure that we know what is happening in the community, and how this impacts our school sites.

Vice-Principal Headley returned to the meeting at 8:06 pm.

- b. Approve Amended Budget for Current Fiscal Year (B. Ketcham)
 - Secretary-Treasurer Ketcham provided highlights on the 2022-2023 amended budget:
 - 2023 Amended budget: \$ \$98,174,705 consists of the Operating Budget (\$78M) along with capital assets, special purpose funds and capital funds.
 - The revised anticipating annual deficit by June 30, 2023, is \$564,436, a reduction of approximately \$640K from the preliminary budget passed in May 2022. The District has seen an increase of regular student enrolment which have increased revenues by over \$400K.

 - THAT the BCSTA request that the Ministry of Education and Childcare continue the student and family affordability fund as an annual targeted fund provided to school districts beyond June 30, 2023.
 - THAT the BCSTA request that the Provincial government fully fund exempt staff compensation based on the new salary grids published by BCPC.
 - Trustee Sluis stated that with the support of the Trustees she will be voting in favour of these two motions as presented. Chair Dhaliwal confirmed that there is no opposition to Trustee Sluis voting on these two motions.
 - There will be a bi-election for the role of BCSTA Vice-President, and the Interim VP.
 - Trustee Sluis attended the BCSTA Metro meeting last week, and noted that there
 were elections for executive positions which included Trustee Danielle Connelly
 being acclaimed to the position of Vice-President. Both Trustee Sluis and Chair
 Dhaliwal congratulated Trustee Connelly on this accomplishment

Dear Chair Dhaliwal,

At the Council Meeting on January 30, 2023, New Westminster City Council passed the following motion:

That Council direct staff to forward a letter to New Westminster School District No. 40 formally inviting them to jointly develop a renewed Child Care Protocol between the City of New Westminster and the School District.

This motion recognizes that quality, accessible and affordable child care provides significant benefits for children, families, and the larger community, and that the City and the School District play important facilitative roles in helping maintain, secure and develop licensed child care spaces within their collective control.

Recognizing the benefits of cooperation, the City has a long history of collaborating with the School District to address child care needs, including through its original Child Care Protocol with the School District in 2009. Several recent initiatives provide an opportune time to develop a new Protocol.

First, the expanded mandate of the Ministry of Education and Child Care seeks to better integrate child care and early childhood educators into the overall K-12 school system. Developing a Protocol would align with this mandate and leverage the Ministry's increased involvement to help realize much needed child care spaces, including better positioning the City and School District to realize funding under the Child Care BC New Spaces Fund or similar programs.

Second, the City and School District each currently lease space to a number of non-profit child care operators, which represents a significant percentage of the non-profit child care spaces in New Westminster. Developing a new Protocol is important to maintaining and expanding these spaces, and in meeting the child care needs of children, families and the larger community.

Through this formal letter, the City is seeking a formal commitment from the School District to participate in collaboration with the City to develop a new Child Care Protocol.

Should the School District agree to formal collaboration, City staff in the Community Planning section would seek to work directly with the new School District Manager of Early Learning and Child Care, a position created to support the Ministry's expanded child care mandate, and other key stakeholders.

We look forward to your response, and future collaboration towards the development of a new Protocol.

Mandate:

- Identifying issues and opportunities related to affordable housing and child care and bringing them to the attention of the Affordable Housing and Child Care Task Force;
- Serving as the liaison between the broader community and the Task Force on issues and opportunities related to affordable housing and child care;
- Assisting staff in monitoring the affordable housing and child care situation and proposing and/or evaluating related actions;
- Informing the review and development of City policies, plans and strategies related to affordable housing and child care.

Ileana Neilson has applied to the committee to replace Tanis Anderson. Ileana started last year and is New Westminster School Districts Manager of Early Learning and Child Care.

Environment and Climate Change Advisory Committee

Mandate:

John has been a member of the Environment & Climate Advisory Committee (EnCAC) with the City of New Westminster (chaired by Councillor Nadine Nakagawa) for 2 years. John attended meetings on a bimonthly basis. He has since applied to be reappointed to the committee. The meeting dates for 2023 are to be determined.

As outlined in its mandate, the role of the Environment and Climate Advisory Committee is to respond to questions from and advise the City's Environment and Climate Task Force on:

- Bold actions related to corporate and community energy and emissions with the goal to have net zero emissions by 2050 and aggressive benchmark targets between now and 2050.
- The effective implementation of the Environmental Strategy and Action Plan with actions
 to protect and enhance biodiversity, natural areas, and the City's urban forest to improve
 ecological health, habitat, and community livability.
- Methods to engage the community, particularly the more vulnerable members of the community.



- Monitoring progress towards achieving the City's environment and climate objectives.
- Any other environment or climate matter referred to the Committee by Council.

Facilities, Assets and Public Realm Advisory Committee

Mandate:

This Committee's role is to ensure all major projects incorporate high standards of project delivery and measures to mitigate impact on climate change.

To advocate on behalf of the community:

- to advance key civic projects;
- to ensure City projects are universally accessible and inclusive;
- in the development of a land management strategy;
- in the assessment of need and aspirations to inform planning for future facilities, parks, and public realm improvements;
- on matters related to infrastructure assets for continuous and sustainable service delivery.

To advise Council and the Facilities, Infrastructure and Public Realm Task Force on Facilities, Infrastructure and Public Realm issues referred to the committee for further examination.

The vision/goal of this Committee is to engage and consult residents on civic capital projects with a direct link to Council's Strategic Priorities.

Matt was sworn in as an active voting committee member on February 3, 2021. Matt has applied to be re-appointed.

Restorative Justice (RJC)

Mandate:

The role of the Restorative Justice Committee is to provide assistance in expanding the use of restorative justice in New Westminster, as well as oversight for the funds that the City provides to Communities Embracing Restorative Action (CERA).

Pam Craven is an active voting member of the committee and has reapplied to be appointed.

Sustainable Transportation Advisory Committee

Mandate:

This Committee's role is to advise the City's Sustainable Transportation Task Force on:

- Implementing the Master Transportation Plan (MTP) actions and policies with respect to inclusive and sustainable transportation that supports everyone;
- How the City prioritizes vulnerable road users as we adapt to changes in mobility;



 Community, stakeholder, and specialist perspective with respect to implementing sustainable transportation initiatives in response to the Climate Emergency.

2009 Childcare Protocol Agreement

Child Care Protocol between the City of New Westminster and School District #40

Purpose:

The City of New Westminster (the City) and School District No. 40 (SD #40) recognize that licensed child care is an essential community-based service and that it makes a significant contribution to the social and economic development of New Westminster. They also recognize that licensed child care is an investment in the future, as quality care is associated with improved child outcomes, including school readiness and success.

For the above reasons and others, the City and SD #40, as major landowners and operators of facilities, agree to work together under this Child Care Protocol to maintain, stabilize and increase the viability of existing licensed child care spaces within their collective control, and to plan for and develop, if feasible, new child care spaces on their collective lands. They also agree to advocate for increased senior government funding to develop a comprehensive child care system. A comprehensive child care system is one that includes the provision of quality programs that are accessible and affordable.

Objectives:

The City and SD #40 agree to work towards the following objectives:

- To maintain the existing number of licensed child care spaces (so that there is no loss of licensed child care spaces as a result of issues within their collective control).
- To stabilize existing child care spaces, including ensuring the provision of adequate, quality space and sustainable lease arrangements.
- To plan for and develop new child care spaces on their collective lands, if feasible, and to promote joint use of space for all types of licensed child care.
- To continue to participate on the Early Childhood Development (ECD) Public Partners' Committee to develop four ECD hubs serving six neighbourhoods in New Westminster.
- To explore opportunities for licensed child care and early childhood development arising from the construction of new schools in New Westminster.
- To increase public awareness of the significant social and economic benefits associated with licensed child care and early childhood development.
- To advocate for increased senior government funding to develop a comprehensive child care system in New Westminster.

Rationale:

Quality, accessible and affordable child care provides significant social and economic benefits for the recipient community. Quality child care has a direct relationship to school readiness and success, parental support, literacy development, poverty reduction, and community engagement. Accessible and affordable child care also enables parents to work and contribute to the local economy; alleviates dependence on income assistance; and is a major factor in the location and relocation decisions of both families and businesses. Research suggests that for every dollar spent on high-quality early childhood development and care, there is a two dollar pay off to society (Cleveland and Krashinsky, 1998).

While the funding and regulation of licensed child care is primarily a Provincial government responsibility, the City, SD #40 and other community shareholders can play an important role in the planning, development, monitoring and coordination of child care.

Although the City and SD #40 do not directly provide licensed child care, they do support non-profit societies and/or associations to deliver quality, accessible and affordable child care within their facilities and on their grounds. They can also work together to create a more focused, comprehensive and integrated approach in supporting existing child care spaces and creating new ones.

Background:

The impetus for this Child Care Protocol came from the City of New Westminster's Child Care Strategy (February 16, 2009). This strategy provides an overall framework and long-term direction with regard to child care in New Westminster. The report recognizes the importance of school-based, licensed child care facilities to meeting the child care needs of parents and students and it recommends the need for more collaborative planning related to child care between the City and SD #40.

The strategy contains the following recommendation:

That a Child Care Protocol be developed whereby the City and SD #40 jointly work to stabilize and increase the viability of existing child care programs so that there is no loss in spaces within their collective control and that they plan for and develop new child care spaces on City/School District lands and promote joint use of space.

On September 29, 2009, the School Board also endorsed the Child Care Strategy.

Regarding moving forward, much of the groundwork has already been laid, as both the City and SD #40 participate on the ECD Public Partners' Committee, along with Fraser Health, the Ministry of Children and Family Development and the United Way of the Lower Mainland. This committee is working to develop four ECD hubs serving six neighbourhoods in New Westminster.

Guiding Principles:

The City and SD #40, under this Child Care Protocol, will be guided by the following principles:

Quality: Quality child care is child care which supports the child's emotional, intellectual, physical and social development and assists and complements the family in its child-rearing role. Research and experience indicate that the predictors of quality programming include: the existence of and compliance with licensing standards; the provision of specific staff training in child development and early childhood education; the effective administration of the programs; the involvement of parents in the care option of their choice; and the provision of sufficient operating funds and program resources to support care that is developmentally and individually appropriate.

Accessibility: Accessible child care is child care in which there is appropriate and adequate capacity for all families and children who require it. This means an integrated continuum of services for children from birth to 12 years of age in developmentally appropriate programs for infants, toddlers, preschoolers and elementary school-aged children; the planning, coordination and delivery of child care services at the neighbourhood level; the provision of culturally and linguistically appropriate services; and the development of physically accessible facilities that promote the full inclusion of all children.

Affordability: Affordable child care is child care which provides access to quality care for all families regardless of income. It is adequately funded by senior levels of government and offers subsidies to families to make up the difference between their ability to pay and the actual cost of child care.
