When using technology, I will...

- Be prepared to learn each day
- Always bring my best
- Use technology appropriately
- Protect myself online
- Be kind, respectful and supportive
- Keep my device in good working condition
- Treat all technology with care

About my personal device: I will...

- Bring my device fully charged everyday to school.
- Take my device home everyday
- Bring my power cord each day or leave an extra one at school.
- Label my device, power cord and case with my full name.
- Safeguard my device in a sleeve, backpack and/or protective case.
- Keep my device software up to date and legal
- Install an up-to-date virus protection software
- Use a screen lock or password on my device
- Personalize my device in school appropriate ways to easily recognize it. Device personalization must not violate the School District Guidelines.

Digital Citizenship and Online Safety: I will...

- Follow the **District Student Technology User Agreement** guidelines.
- Participate in lessons on Digital Citizenship
- Keep my passwords private
- Report misconduct or unsafe situation to a trusted adult
- Take ownership and be a part of the solution

Before and After School, I will...

- Keep my device in my backpack when traveling to and from school
- Avoid placing excessive amount of additional object in my backpack that could damage my device
- Make arrangements with a parent, coach, or other trusted adult to keep my device safe during after-school activities

During Class Time, I will...

- Keep my device with me or locked in the classroom/locker at all times.
- Be the only person using my device
- Only use my device when permitted by my teacher during class time, for learning activities.
- Only work on the educational task assigned by my teacher
- Always mute my device sound unless my teacher gives me permission.
- Respect and care for my device and other's devices
- Keep my power cord neat and out of people's way
- Not eat or drink while devices are in use
- Troubleshoot my device issues first, then seek help if needed

During Recess and Lunch, I will...

- Always place my device in a locked classroom or my locker
- Ask an adult for assistance if I need it

Possible Consequences if BYOD expectations are not followed:

- Device collected and turned it in to the office. Meet with an administrator in the office to retrieve it.
- Loss of district technology privileges
- Disciplinary action through the school or District code of conduct.
